ANIMAL CARE - THE SHELTER IS THE FOCAL POINT OF ALL SPCA SERVICES FOR ANIMAL RESCUE, SHELTER, CARE AND ADOPTIONS. 986 ANIMALS WERE ADOPTED TO NEW HOMES, 370 ANIMALS WERE RETURNED TO THEIR OWNERS. 1,057 ANIMALS WERE SPAYED OR NEUTERED THROUGH THE SPCA PROGRAM. THIS IS AN INCREASE IN SPAY / NEUTER ASSISTANCE OF 44%.

THERE WAS A DECREASE IN SHELTER EUTHANASIA OF 31% IN 2016.

A BARN CAT PROGRAM HAS BEEN ESTABLISHED FOR CATS THAT ARE NOT SOCIAL BUT NOT AGRESSIVE. BARN OWNERS PROVIDE HOUSING, FOOD AND WATER FOR THESE CATS IN RETURN THE CATS PROVIDE RODENT CONTROL.
